

Monitoring Locations

1 Introduction

This report has been completed to meet the requirements of Section 66(6) of the *Protection of the Environment Operations Act 1997* and the NSW Environmental Protection Authority's (EPA) *Requirements for Publishing Pollution Monitoring Data* (EPA, 2013). This report summarises the required monitoring data under *Environmental Protection Licence 11569* (the EPL) (see Table 1) and *Development Consent 265-10-2004* (the Consent) (see Table 2) for the Karuah Hard Rock Quarry (the Quarry).

2 AIR QUALITY MONITORING

Dust emissions generated by the Quarry operation must not cause additional exceedances of ambient air quality criterion outlined in *Schedule 3, Condition 14* of the Consent (see Table 3, Table 4 and Table 5). Deposited dust and TSP/PM $_{10}$ monitoring is undertaken at the locations listed in Table 6.

All dust monitoring is undertaken in accordance with the *Approved Methods of Sampling and Analysis of Air Pollutants in NSW* (EPA, 2007).

2.1 Deposited Dust Monitoring

Deposited dust results for May 2020 and the year to date (YTD) from the EPL anniversary (16 January) are shown in Table 7.

Note 1: DDG4 was not able to be analysed for period 9/4/2020 to 7/05/2020 due to sample jar breaking during collection and transportation to the laboratory.

Monitoring results indicate that for the period 7 May 2020 to 4 June 2020, the insoluble solid levels recorded at DDG 1 to DDG 4 monitoring locations were below the project criterion of 4 g/m²/month.

2.2 HIGH VOLUME AIR SAMPLING

The TSP and PM₁₀ results for May 2020 and the YTD average are shown in are shown in Table 8.

All monitoring results to the end of May 2020 were compliant with the long term and short term impact assessment criteria outlined in *Schedule 3 Condition 14* of the Consent (see Table 3, Table 4 and Table 5).

3 BLAST MONITORING

The following conditions from the EPL refer to blast management:

- M6.1 The licensee must monitor all blasts carried out in or on the premises at or near the nearest residence or noise sensitive location (such as a school or hospital) that is likely to be most affected by the blast and that is not owned by the licensee or subject of a private agreement between the owner of the residence or noise sensitive location and the licensee relating to alternative blasting limits.
- L4.1 Blasting in or on the premises must only be carried out between 0900 hours and 1500 hours, Monday to Friday.

 Blasting in or on the premises must not take place on weekends or Public Holidays without the prior approval of the EPA.
- L4.2 The overpressure level from blasting operations carried out in or on the premises must not:
- a) exceed 115 dB(L) for more than 5% of the total number of blasts carried out on the premises within the 12 months annual reporting period; and
- b) exceed 120 dB(L) at any time at any residence or noise sensitive location (such as a school or hospital) that is not owned by the licensee or subject of a private agreement between the owner of the residence or noise sensitive location and the licensee as to an alternative overpressure level.
- L4.3 The ground vibration peak particle velocity from blasting operations carried out in or on the premises must not:
- a) exceed 5mm/second for more than 5% of the total number of blasts carried out on the premises within the 12 months annual reporting period; and
- b) exceed 10mm/second at any time at any residence or noise sensitive location (such as a school or hospital) that is not owned by the licensee or subject of a private agreement between the owner of the residence or noise sensitive location and the licensee as to an alternative ground vibration level.

There were two blast was conducted in May 2020 (see Table 9). Monitoring results show that the overpressure and ground vibration were below the EPL criteria at the nearest residence.

4 Noise Monitoring

Noise generated by the Quarry operation must not exceed the criteria specified in *Schedule 3, Condition 14* of the Consent (see Table 10) at the locations identified in Table 11.

4.1 ATTENDED MONITORING

Attended noise monitoring is required to be undertaken at the two nearest residence (NM1 and NM2) biannually.

Attended noise monitoring was undertaken on 18 April 2020, see results in Table 12.

The results of the attended monitoring (Table 12) show ambient noise levels include noise sources such as traffic from the nearby Pacific Highway, wildlife such as insects and birds, and farm activities. The Quarry operation was inaudible at location NM1 and NM2.

4.2 UNATTENDED NOISE MONITORING

Unattended noise monitoring is required to be undertaken at the two nearest residence (NM1 and NM2) biannually.

Unattended noise monitoring was undertaken during April 2020, see results for NM1 in Table 13 and NM2 in Table 14

The attended noise monitoring conducted during April 2020 identified that the Quarry was not audible at location NM1 or NM2.

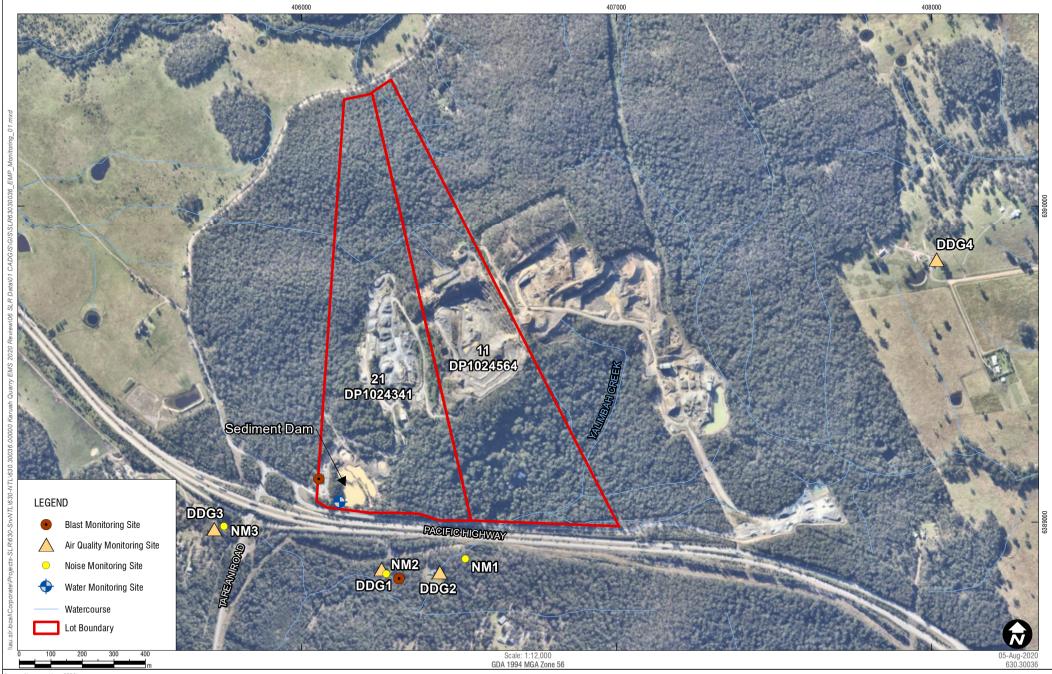
5 SURFACE WATER MONITORING

Condition *L2* of the EPL outlines the requirement to monitor surface water discharges from the Quarry via the licensed discharge point (LDP001). There were no discharges from LDP001 during the month of May 2020.
